Trustee Replogle reported that the water bill program is proceeding as scheduled and is now covering delinquencies of \$250.00. Replogle also informed the Board of the spray patching in progress and the chipping to be done in the near future.

Finally, Replogle brought in price estimates for a new mower which Brian Hild requested for the Public Works Department. This will be discussed in depth at the August 15 meeting.

Trustee Zuercher reported that the water plant roof was leaking and that Brian had received a couple estimates for repair. This will be an agenda item for the next meeting.

Trustee Harding moved to transfer \$24,080.76 from General Savings to Police Operations Checking to cover bills and payroll. Zuercher seconded.

Trustee Perry reminded President Bong and the Board that a new Zoning Board member is needed.

President Bong reported that both *Winning Communities* and *Tremont Betterment* are recommending the tear down and removal of the old *Super Valu* building with emphasis on improvements to the new Senior Center and increased parking on that site. Sketches will be forthcoming as well as new ideas.

Hana Mueller and Zach Olson, of AFLAC, were in attendance to present and explain the benefits and different programs AFLAC can offer to village employees. Trustee Scott will attempt to set up an informational meeting conducted by Mueller and attended by all interested employees.

Trustee Zuercher moved to grant a Class A liquor license to Dan Steinbach who will open *The Twisted Spoke* where *The Wild Turkey Saloon* had been. Stuber seconded. The Liquor Commission had recommended the license after meeting at 6:30 PM.
