Village attorneys and Unsicker/Baer Land Trust attorneys have been in communication concerning the detachment. There will be continued discussions concerning the Unsicker/Baer Land Trust Detachment.

Trustee Zuercher made a motion to approve Ordinance 23-116, amending chapter 77 (Traffic Schedules) of the Village code and Trustee Getz seconded.
