Trustee Zuercher moved to approve the minutes for the regular meeting held on January 20, 2014, and Scranton seconded

Trustee Replogle informed the Board that during their annual inspection of the water tower, *Corr Pro* recommended the purchase and placement of a new rectifier for cathodic protection. This will cost approximately \$4800.

Also, Replogle reported that state and county salt supplies are low, and Public Works Superintendent Brian Hild will purchase water softener salt to be mixed with our existing slag. In addition, Hild has been in contact with R.A. Cullinan should the Village need extra help in moving large build-ups of snow.

New winter tires for our snow plows will be purchased at a cost of \$1600. This will help prevent slippage recently experienced.

Trustee Harding moved to transfer \$16,198.86 from General Fund Savings to Police Operations Checking to cover bills and payroll. Replogle seconded.

President Bong says that he, along with Trustees Scranton and Harding, will attend a meeting in Tremont to discuss *Enterprise Zones*. Pekin and Morton representatives will also attend.

Following a discussion, during which Trustee Replogle informed the Board that a pre-liminary estimate of \$76,597.50 was presented, Trustee Zuercher moved to direct Village Engineer Ric Creasy (Austin Engineering) to put out bids for a storm sewer project on the North side encompassing sections of Locust, Elm, and Greenfield Streets. Replogle seconded.

President Bong said Conrad Beachy hopes to begin Phase II of the Village Hall renovation in the middle of March.

In final business, Attorney Dick Wherry reported that he is currently working on the swimming pool ordinance but hopes to get more input from the Board. Police Chief Mike Dodwell says that all full-time officers have received Taser training and further training is being scheduled for part-time officers.
