Trustee Replogle moved to approve the minutes for the regular March 21 meeting, and Zuercher seconded. (Changing Winning Communities to Governor's Home Town Award)

Trustee Scott moved to approve all bills incurred since March 21, and Conover seconded. AYES: All NAYS: None Motion carried.

Trustee Zuercher reported that the '03 squad car is in the shop facing a \$2700 bill for struts, oil leak, transmission line, and engine oil cooler. Police Chief Mike Dodwell distributed emergency siren operation instructions to all Board members.

Engineer Ric Creasy was present to report that he and Superintendent Brian Hild met to inspect pavement areas in need of repair. He presented repair options that would be most economical to the Village. Costs will run approximately \$157,000 to \$177,000. No decisions were made at this time. Trustee Conover moved to approve the final draft of the Community Center use form which now will be based on hours of use, and Zuercher seconded.

Trustee Harding moved to transfer \$11,774.54 from General Savings to Police Operations Checking to cover bills and payroll. Zuercher seconded.

In regard to police vehicle financing, Trustee Zuercher moved to take a three year loan at 4.5% from the Tremont First National Bank. Replogle seconded. Zuercher then amended his motion to include "Tremont First National Bank or Tremont Community Bank"
