First National Bank Grant

The First National Bank in Tremont Receives Grant to Support Local Nonprofit Organizations Affected by the Pandemic

The First National Bank in Tremont has been awarded a \$20,000 COVID-19 Relief Program grant from the FHLBank Chicago to support local nonprofit organizations affected by the pandemic.

These funds have been forwarded to the Tremont Betterment Association to help offset the losses due to the cancellation of the Tremont Turkey Festival this year. Proceeds from this festival have funded a multitude of Tremont community organizations and activities for the past 54 years and the cancellation leaves a huge deficit in funds for next year. According to June Kidd, President/CEO of The First National Bank in Tremont, "We are thrilled to be able to forward these funds to the Tremont Betterment Association. This is what community banking is all about!"

Materials Return

The library's book drop, located on the back of our building, will be open with limited hours from 9:30AM-1PM Monday-Friday until further notice. (The next step will be opening the bookdrop 24/7. We'll let you know when we've reached that phase!) Please practice safe social distancing when using our back parking lot and patio.

Books must be quarantined for 72 hours before being returned, so items will remain on your card for 3 days after returning.

Remember there are no fines at this time. There is no obligation to return your items yet. Your items are not due until June.

This is the first step to us getting ready to be able to start in-person services again (yay!) We would like to get as much of our collection back, quarantined, and ready to be checked out again before we open for curbside.

Did you know...?

A Key Business Corner

Catty-corner from the grade school learning garden – or otherwise known as the SW corner of E. South and S. James, has always been a "key" business corner. Today, The Library Store warehouse stands in that location. The Library Store quietly provides supplies and furniture to libraries and schools nationally.

But if we peel back the layers, it was the site of the state-of-the-art Sauder Feed Mill, owned by Willis Sauder. Later it was sold to Tazewell Service Company. Then, on March 30, 1982, lightning struck, causing a terrible fire. Al Sanders, the Tremont Fire Chief at the time, said it took two days to put it completely out. Others remember that the water tower was drained in the effort. It was a terrible loss for the community.

Peeling back another layer, we would see the Commercial Hotel, also called the Commercial House Hotel. This hotel would have been necessary at a time when traveling from one place to another was much slower than we are used to, resulting sometimes in an overnight stay. This hotel hosted many guests for several years before being torn down.

Prior to that, it may have been the Tremont House Hotel, 1867-1917. We know about the Tremont House, but still are not certain of the location. More information may turn up that will allow us to see more layers. Next time you pass that business corner, try to picture it as it was in years past.

Tremont Park District

Tremont Area Park District is committed to providing safe, clean, family-friendly facilities and programs. We continue to follow the provisions set forth by state, federal, and local governing bodies, as well as public health organizations in relation to COVID-19 safety guidelines.

After careful consideration, TAPD has made the difficult decision to cancel the 2020 swim season at Tremont Public Pool. A variety of factors lead to this decision, including informed discussion with area park district leaders and the Tremont Area Park District Board of Commissioners.

The Illinois Department of Public Health is not currently allowing the operation of any public swimming pools within the state of Illinois. The Centers for Disease Control currently advises park users not to use splash pads, playgrounds, or water park features.

Based on these recommendations, along with the financial considerations resulting from attendance limitations and sanitizing procedures set forth in Gov. JB Pritzker's signed Executive Order 2020-32, we believe it is in residents' best interest for the pool to remain closed.

In order to maintain the integrity of the new pool liner, installed in 2019, we are following cleaning and preparation procedures recommended by the installation company.

We recognize the pool is a favorite summer pastime. The decision to remain closed was not an easy one. While we have specific expertise in providing safe, clean, family-friendly facilities and programs for our residents we are not experts regarding communicable diseases and must, therefore, defer to the guidance of public health experts.

Obtaining a Fishing Permit for Tremont Lakes

We now have sales open for Tremont Lakes Fishing Permits via telephone and online. The instructions and options for purchasing a fishing permit are listed on our website: www.tremontpark.org.

The Lake areas are open for use following the social distancing guidelines set by the CDC as well as the rules and regulations posted. Rules and Regulations are posted at each of the lakes and can also be found on our website.

Parks and Lakes

At this time residents may use our park trails and walking areas following the CDC social distance guidelines. The public restroom facilities at both City and Cullinan Park are not currently open to public use.

Unfortunately at this time, By Executive Order of the Governor, all playground equipment is closed for use.

The Tremont Park District looks forward to opening our services as soon as the restrictions are lifted.
