Following discussion, Trustee Replogle moved to uphold the Zoning Board recommend-
ation to grant a 12 foot variance to PLR to attach an awning above the west door at 103
W. Pearl Street. Harding seconded.AYES: AllNAYS: NoneMotion carried.

Trustee Harding moved to transfer \$15,279.72 from General Savings to Police Opera-tions Checking to cover bills and payroll. Scranton seconded.AYES: AllNAYS: NoneMotion carried.

Trustee Getz reported that the Sampson Street striping was completed last Saturday morning (7-30).

Heather Wagenbach, a consultant with *HUB International*, presented alternative insurance information to the board outlining possible plans that she feels will save the Village and employees money while offering the same coverage as *Central Management Services*. Wagenbach will meet with covered employees August 15 to answer questions. President Bong would like a Board decision by September 19.

Trustee Harding reminded the Board about a lot size and zoning study by the Zoning Board to solve problems with out-dated zoning and sub-standard lot sizes.

Kerry Martin was present to inquire about the possibility rezoning property along W. Pearl St. (Rte 9) from R-1 to commercial or business. President Bong and Zoning Chair Eric Hansen agreed that before any long term plans are made, IDOT should be contacted to see how the scheduled Route 9 roadwork will affect those properties. Bong and Hansen will contact IDOT for a meeting soon.

In final business, Eric Hansen informed the Board that a pre-construction meeting with *National Power Rodding* will take place on Friday, August 5. The sewer cleaning and televising project should be completed within 30-45 days following that meeting.
