Postmaster Bev Freehill was present to get a better understanding of the rules regarding mailboxes at multi-family dwellings. She was told that it was the owner's responsibility to approach the Zoning Board for a special use permit.

Trustee Harding moved to approve **Ordinance 17-108**, known as the Appropriations Ordinance for the Village of Tremont, and Scranton seconded.

Trustee Scranton moved to adopt **Ordinance 17-109** authorizing the issuance of Waterworks and Sewerage Revenue Bonds in an aggregate principal amount not to exceed \$5,000,000. Getz seconded.

Trustee Scranton moved to adopt **Ordinance 17-110** authorizing the issuance of General Obligation Refunding Bonds in an aggregate principal amount not to exceed \$600,000. Replogle seconded.

In final business, Bev Freehill had questions regarding the mowing of state property behind her house, the purchase and placement of new street signs throughout Tremont, and the repair of Maple Court. Financing proves to be the problem in all three cases. No decisions were made.
