Dale and Sam Stuber from *Stuber Land Design* were in attendance to present concepts and graphics in accordance with *Winning Communities*' Sampson Street Revitalization. Highlighting the Sampson/Walnut Streets intersection as the centerpiece, planting beds, green spaces and social areas will all work together in creating a "complete street". Work could be done in phases and be coordinated with the Sampson Street infrastructure project.

President Bong reported that tile at the Community Center is loosening and coming up which creates an accident problem as well as an aesthetic one. Bong has spoken to Mike and Tom Vonderheide concerning solutions. Carpet tile, sheet vinyl and vinyl plank flooring will all be considered as well as the need for better crawl space ventilation.

Trustee Getz raised the question of creating or entering into a Municipal Road District and whether or not the Village could tax for that. Attorney Dick Wherry thought not but will further research the idea.

Tremont School Superintendent Jeff Hinman invited any or all of the Village Board to attend a proposed leadership summit to discuss diversity in Tremont. The goal of this dialogue would be a better understanding of the diversity in the make-up of the school system as well as the Village itself.
