Eric Hansen reported that contracts for Phase II of the water/sewer rehab program will be available at the next Board meeting. He has also been meeting with *Stuber Land Design* so as to coordinate improvements with the Winning Communities downtown project.

Trustee Getz will meet with Eric Hansen in hopes of setting up guidelines, procedures and rules regarding sidewalk reimbursement and alley use and maintenance.

Trustee Getz moved to approve **Ordinance 18-106** amending the water & sewer base rates for the Village of Tremont. Replogle seconded.
