Trustee Scranton moved to approve the Executive Session minutes for September 4, and Getz seconded. AYES: All NAYS: None Motion carried.

BILLS

Trustee Scranton moved to approve all bills incurred since September 4, 2018, except forthe Sensus bill which was removed from warrants. Replogle seconded.AYES: AllNAYS: NoneMotion carried.

Trustee Replogle reported that the Zoning Board will meet on Thursday, September 27 and will discuss solar panels among other items.

Trustee Harding moved to transfer \$18,970.85 from General Savings to PoliceOperations Checking to cover bills and payroll. Getz seconded.AYES: AllNAYS: NoneMotion carried.

Trustee Harding also moved to transfer \$23,205.00 from General Fund Savings to MFT
as reimbursement from Compliance Review, and Scranton seconded.AYES: AllNAYS: NoneMotion carried.

Trustee Getz reported that he and Eric Hansen met to discuss and create a plan for ADA sidewalks. Looking at budget numbers, they thought City Park might be the first site to address and other logical sites would follow. Compliance at and near the park would cost approximately \$38,000.

President Bong has spoken to *Ragan Communications* and *Supreme Radio Communications* regarding the moving and/or purchasing of storm/tornado sirens for the best citywide coverage. Studies will continue.

Trustee Scranton moved to set Wednesday, October 31, as official trick-or-treat night forthe Village of Tremont, and Getz seconded.AYES: AllNAYS: NoneMotion carried.

Following discussion, Trustee Scranton moved to designate \$500 per full-time Water &Sewer employee per year for clothing allowance. Harding seconded.AYES: AllNAYS: NoneMotion carried.

In final business, the Board continued its discussion of possible insurance packages and employee contributions and will continue looking at options.
