Did you know...?

Tremont Female Seminary

The Female Seminary was supposed to stand in the center of the Tremont's public square, demonstrating the great value placed on education in Tremont, right from its beginnings. In today's context, the word seminary is used to mean a college that prepares students to be ministers, priests, or rabbis, according to dictionary.com. However, in 1850 when the Tremont Seminary was established, the word had a much different meaning. In the 1800s and early 1900s, education for women was not very common. A Female Seminary was a private educational institution.

On April 3, 1850, the first meeting of the "Stockholders of the Tremont Female Seminary was holden." 96 shares of stock were sold, most individually, within just a few weeks. Almarine Hayward was hired to construct a 44 X 28 foot two story building in the public square (today's City Park.) However, many citizens of Tremont objected to that location for a private school. That was the first of the issues the fledgling school encountered. Very shortly, some stockholders were not paying their assessments and the budget had to be cut from the beginning.

Another location was found at the southwest corner of Park and Locust Streets, where the large grain storage bins are today. The first principal was Miss Harriet Kingsbury with an annual salary of \$350. Miss Abby Kingsbury was hired to teach for a salary of \$300. The seminary opened on November 17, 1851 with 27 students, though the building was not quite finished. The school year consisted of three 14-week terms. Early historians say it was one of the finest institutions of its kind in all of Illinois. The pupils came from all over the country.

The impressive list of subjects and their charges were:

Latin, Algebra, Geometry and Trigonometry - \$7.00

History, Logic, Rhetoric, Physiology, Anatomy, Natural Philosophy, Chemistry, Botany, Moral and Intellectual Philosophy - \$5.50.

Reading, Writing, Arithmetic, Geography, Grammar - \$4.50.

Extra charge for Music, French, Drawing & Painting - \$4.50.

And all taught by one teacher! She taught for one year and was replaced by Miss Lucy Andrews.

In 1853, the tuition fees were dropped to \$5.00, \$4.00 and \$3.00.

The challenges were many, such as, some stockholders failed to pay or only paid while their own children attended, a lack of equipment, and low enrollment. There was a depression in the late 1850s, and though many efforts and sacrifices were made, in 1858, the school closed. It reopened at least twice, but a recession followed, the Civil War was brewing, enrollment dwindled, and it could not sustain itself.

On May 20, 1861, the school's prize possession, its piano, was rented out quarterly for lessons in the school building by several teachers. The board approved the loan of much of the equipment to the Tremont High School, which at that time was located in the vacated Courthouse. Later, that

school evolved into the Tremont Community Unit District 702.

On July 5, 1862, it is recorded that the board requested of an original board member, Mr. Tompkins, to move his hogs from the Seminary yard. Months later, the property and equipment sold at a public auction on May 20 1864.

The Seminary building was moved to the site of the old Bell School, which had been destroyed. The old seminary was used for several years as a public grade school and stood on East Walnut Street, where the Baptist Church addition is today. That school was used until 1892, when a new school was built where the Tremont Grade School stands today.

The Tremont Seminary had high ideals, and though in the end it failed, it set the standard for excellence in education in Tremont.
